Any dispute, potential breach of contract, difference or question which may arise at any time hereafter between the Sponsor and the IMVELO Programme Steering Committee, touching the true construction of this agreement, or the rights and liabilities of the parties thereto, shall, unless otherwise herein expressly provided, be referred to the decision of an arbitrator to be agreed upon by both parties in accordance with the subject to the provision of the Arbitration Act 42 of 1965 or any statutory modification thereof for the time being in force.

No variation or consensual cancellation of this agreement shall be of any force or effect unless reduced in writing and signed by both parties.
