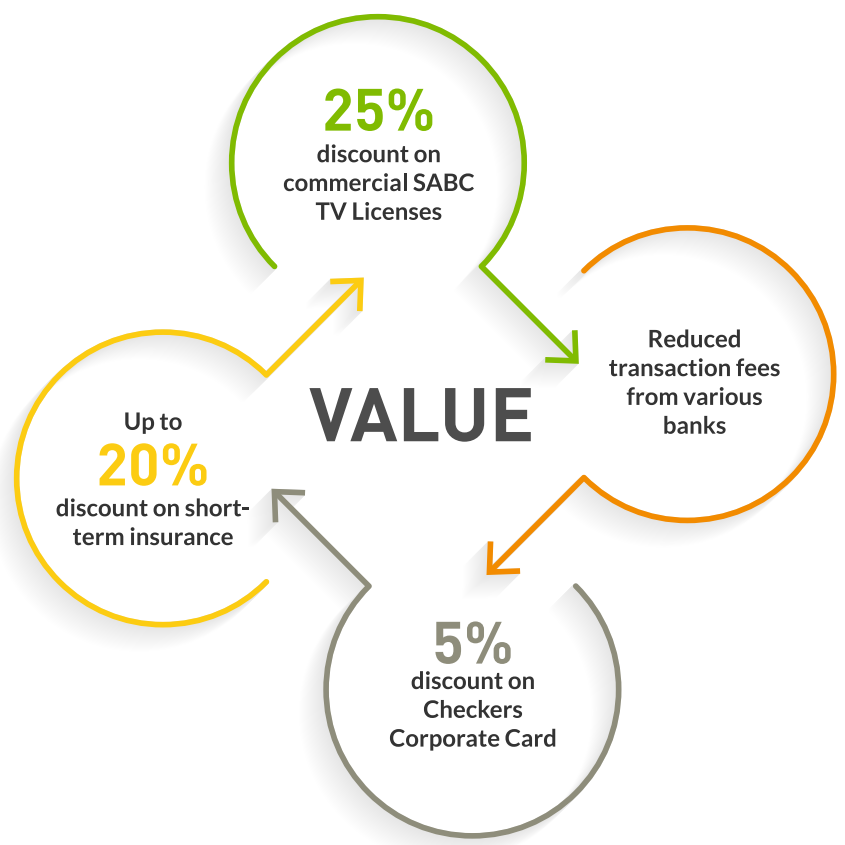

- **Registered as an Employers' Body:**
  - Enables FEDHASA to fight unfair legislation on your behalf, e.g. the extension of the Bargaining Council

- **Registered as a Trade Association to fight and lobby on your behalf:**
  - Lobbying for favourable trading environment / easing of lockdown regulations
  - Petitioning of insurance companies to pay out on Business Interruption cover
  - Pressuring Government to expedite vaccination roll-out
