The Mpumalanga Economic Regulator (“MER”) hereby invite applications for site operator and independent site operator licences.

The RFA issued on 08 April 2022 describes the process that the MER will follow to consider applications for site operator and independent site operator licences. This invitation is open from the date of publication of this notice until such time the Board announces its closure or publishes a revised RFA. The aforementioned RFA is open for clarification questions until 09 May 2022.

Prospective applicants for independent site operator licences should note the following licences already issued:

- Ehlanzeni District: One (1) licence with 40 limited payout machines;
- Gert Sibande District: One (1) licence with 40 limited payout machines; and
- Nkangala District: Two (2) licences with 40 limited payout machines each.

Furthermore, applications for independent site operator licences will be considered on a first-come-first-serve basis.

Interested parties must also note that delays may occur, if significantly more applications are received than originally anticipated.
